



**DIRECTIONS TO THE BOUNCE SPOT**

**From Eastbound 1-80 (ie. Davis, Vacaville, Bay Area)**

1. Go on the US 50 E/Capitol City Freeway towards Sacramento/Tahoe
3. Take the first exit, Harbor Blvd heading south towards the port (0.2mi)
1. Turn left on Industrial Blvd (0.6mi)
2. Turn right at Southport Pkwy (2mi)
3. Turn right onto Promenade (50ft)
4. Turn into first driveway on right (500ft)

**From Westbound I-80 (ie. Roseville, Natomas)**

1. Take I 80 towards San Francisco, after passing IKEA/Reed Exit
2. Merge onto US 50 E/Capitol City Freeway/Business 80 toward Sacramento.
3. Take the first exit, Harbor Blvd heading south towards the port (0.2mi)
4. Turn left at Industrial Blvd (0.6mi)
5. Turn right at Southport Pkwy (2.0mi)
6. Turn right at Promenade (50ft)
7. Turn right into the first driveway (500ft)

**From Westbound I-50 (ie. Sacramento, Folsom, I-5, Business 80):**

1. Take the Harbor Blvd exit, heading south towards the port (0.2 mi)
2. Turn left at Industrial Blvd (0.6mi)
3. Turn right at Southport Pkwy (2.0mi)
4. Turn right at Promenade (50ft)
5. Turn right into the first driveway (500ft)

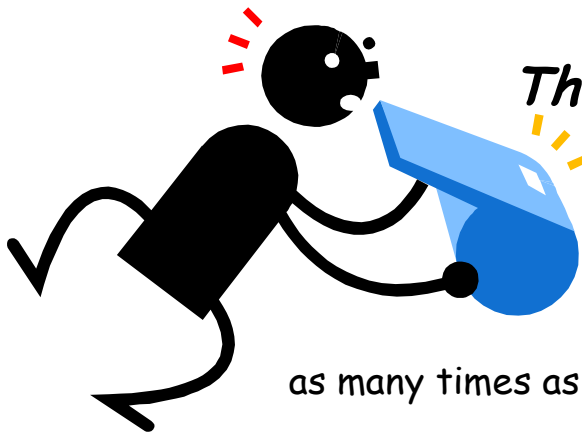
